

- Del Rio Car Show: 8/8 Open for discussion pending state shut down



Coronavirus Update:

I hope that this column finds you all safe and in good health as we struggle to deal with the current pandemic both on a personal, business and club level. The pandemic has certainly caused club members and their region leadership concerns for their personal safety as well as life as it once was prior to the pandemic. With all regions in Zone 7 cancelling or rescheduling events as we enter spring, I know that many of you are itching to get back to normal. However, that does not seem likely as I sit and write this column just a week or so prior to California's anticipated apex in regards to infections in our great state. The big question is when will we get back to normal? I am not an expert and our comeback is so dependent on what each of us does individually to help prevent the further spread of this virus. Keep the faith, we will get out of this and get back to normal soon. It will not happen overnight so be patient.

So what are some of the activities that you as a Porsche enthusiast can do to fuel your passion? Activities such as riding your bike, jogging, or taking the dog for a walk are still allowed. My take on this is that it is ok to take your Porsche out for some exercise too but not in a group of 5-6 Porsches with friends on an unofficial Porsche Club drive. I highly recommend that this type of group activity be highly discouraged as anyone seeing a group of Porsches, regardless of the number, may associate this activity as flagrant disregard of prohibitions against group gatherings and a non-essential activity. Done solo, I think it not an egregious walk around of the stay at home order and no different from a cyclist going for a short ride. Besides, our Porsche still needs to be exercised too. There are many other activities that you can take on at home while under the stay at home order and here are a few ideas to keep you busy;

- 1. Detail your engine compartment
- 2. Fully detail your car's exterior with a clay bar, polish and some paint correction and a good application of wax
- 3. Fully detail your car's interior with a vacuum, carpet steam clean, leather cleaning and conditioning. Also include detailing of your seat rails, fresh air vents, door pockets, glove box, and center console storage.

- 4. Pull your wheels off and give the inside barrels a thorough cleaning to rid wheels of that unsightly accumulation of brake dust and road debris.
- 5. Organize your garage and go through old files and boxes that you have been keeping for years but are unlikely to ever need. Decluttering your storage will go a long way to keeping you positive.
- 6. Write an article for your club newsletter. With many events cancelled there is not much to report on post event.
- 7. Attend the next club board meeting. It could be as simple as attending virtually to see what your board does and the energy required to plan and re-schedule events.
- 8. Support our local advertisers and sponsors. Even though that annual oil or brake fluid change is not due for a few months or miles, take it in early and show your support for our sponsors.
- 9. Get bids on your current automobile coverage to insure that you are getting the best deal possible. Do an annual review of your current coverage. Is it all needed? Do you need a guaranteed value policy for that collector car?
- 10. Post a short article on the club's Facebook page about what you have been doing while under lock down and share any unique Porsche related activities you are thinking of participating in once the lock down ends.

At the PCA National, there have been several events that have been cancelled or rescheduled. Among the events that have been cancelled include several West Coast Club races and Treffen Broadmoor. Refunds have been issued for Treffen so watch your mail. National just announced the cancellation of Parade with refunds already in the works. I know that many members in the region have been looking forward to visiting the desert in late June but due to an abundance of caution and information that was provided by local health officials, it was decided the event be cancelled. Several club racing events across the Zone have been either cancelled or rescheduled including the Zone AX series at Marina April 25-26th, and the club race at Thunderhill on April 25-26th. In addition, Sacramento Valley Region has rescheduled their multi-day, multi-event CRAB event to May 2021 due to the issue with the coronavirus.

At the time of the writing of this column the Werks Reunion in August is still on schedule. Due to unforeseen issues with the current pandemic, events could be subject to change.

On a positive note, most region boards are meeting on a regu-

Ted Fisher - 2006 Cayman S

Don't know if you read the Tech Q&A section in the January 2020 Panorama issue but the 2006 Cayman S Over Rev Report was taken from my car. This report is also called the DME (Digital Motor Electronics) report and if you follow the comments in the BAT ads or any of the forums you will notice that many buyers use it to determine if they will buy a particular Porsche or not.

Usually these reports can only be generated by a dealership but in No Calif there is an Indy I work with; Nico Castellaccio at MIGLIO-RE MOTORWERKS in Lathrup who has the proper testing equipment to do this. Needless to say, every time I go to the shop he downloads the DME report. It not only tells us how I am driving the car but what all the electronics are doing. This is very useful when the goal is to stay ahead of any problems.

Within this report is a section that includes the number of ignitions in six different ranges (997/987 or newer). As Pedro Bonilla said in the Q&A section, anything in the lower levels is nothing to worry about. While under my ownership there have been no change in the number of ignitions between Levels 3 and 6 which is great. Level 2 has gone from 54 Over Revs (OR) at 1705 hrs to 68 OR at 2347 hrs, which is statistically insignificant. The interesting item is that the number of OR's at Level 1 has gone from 1716 ignitions at 2210 hrs to 4953 ignitions at 2394 hrs.

You have to ask; how did I manage to almost triple the number of ignitions in level 1 in just under 200 hrs of operation? In a way, the answer is simple. My Cayman S has the Sport Chrono option installed. While everyone understands that the Sport Chrono is very effective with launch control with a PDK, they might not realize that it also effects the way the engine runs, whether you have a PDK or like my Cayman S, the MT. And this is especially true as it approaches the Rev Limiter.

In a Porsche that does not have Sport Chrono or the option is turned off, the Rev Limiter is activated in a manner that is best described as the Soft Mode. As the engine gets within 5-700 rpm of the rev limit, the DME (also called the ECU) starts to reduce power via fuel and ignition interruptions. If you are looking for full power all the way to the rev limit, it just will not happen. But in a Porsche where the Sport Chrono option is turned on, the rev limit manage-

ment system doesn't do anything until the rev limit is reached. This is known as the Hard Mode which allows the engine to have full power all the way to the rev limit (7200 rpm in the 2006 Cayman S).


Every Porsche has a special sensory experience, especially when driving the car near its limits. But the Cayman is very unique because it is the only Porsche where the drivetrain sits entirely within the cockpit envelope. Even though everything is well insulated with all kinds of sound dampening, any noise it makes (and it can make a lot when pushed) the rear hatch directs that ensemble of sound forward. And let's not begin to talk about the air intake which sits just behind the driver's left elbow. This makes for a very unique experience that just can't be matched.

If you are still wondering how I managed to triple my Cayman's Level 1 OR's, the answer is that I am guilty of enjoying the sensory experience. Whenever I can, either on the street or at the track, I rip the Cayman through the gears. Here it immerses me in an intoxicating rush of speed with the fantastic German engineering making a glorious concerto as I maximize the experience... right to the red line.
