• Tentative date of 5/1; again at Smoky's in Modesto; consider free coffee (Region pays buys cups in advance) to boost attendance

Yosemite/Tenaya Lodge Overnight

- Brian confirmed 5/14-5/16 dates and Larry has paid first night's deposit from region funds
- Brian presented two breakfast and two dinner menus that were approved, dinner options will have one meat or one vegetarian option
- Estimated cost per room is \$1100, with estimated \$800 down payment at registration (first night plus food/gratuity) and \$300 at check in
- Region will pay the estimated \$8805 food/gratuity at check-in, leaving approx \$1300 in region funds until EB pays out after event
- Board agreed that this would temporarily limit cash flow until EB pays out but no other events are scheduled that would require a down payment
- Registration will open 3/15 pending final numbers and stay open three weeks until 4/4, allowing one last push at Dave's Tech Talk
- Board agreed to prioritize anticipate region members first, then open to surrounding regions the last week
- Good news that the park is no longer taking reservations
